## **BUSINESS MANAGER'S REPORT**

Sisters and Brothers, as I sit here and write this article for the Conduit, it is the last week in September. The summer is over, kids are back in school and employment is still very good. We are still getting into Book 2 on a regular basis and currently have 59 travelers working in the jurisdiction. Employment should stay strong throughout the fall and into the winter. With some of the bigger projects just breaking ground now, they should be hiring manpower in

the next few weeks.

August and September have been very busy months here at the hall. We had our annual block party, our annual softball tournament, the EWMC fishing trip, the IBEW Membership Development Conference, the IBEW 3RD District Conference, the IBEW Women's Conference, and the NECA Conference. In October we will have the kids Halloween party and then the kids Christmas party in December.

This October 1st will mark my 8th year as your Business Manager of this great Local Union. Over these past 8 years we have made some significant changes and achievements; all for the betterment of the membership. Here is a list of some of these achievements: Union meeting start time change from 7 pm to 5 pm; having barbeques and pig roast after the union meetings; raffling off barbeques in the summer month union meetings and TV's and other items at the Christmas meeting; taking bus trips every year to the NY Jets and NY Yankee games; doing major renovations to the interior and exterior of the union hall, which includes a new roof, new exterior facade, new portico and patio in the back of the hall, new renovated lobby, new carpet, tile and a new bar in the hall. We started and were chartered by the International, a Local 25 Women's Committee and a Local 25 Veterans Committee. We have made significant changes to the Referral System, which has resulted in 8 years in a row in which we have had full employment with travelers working in the jurisdiction. We started the annual Local 25 College Scholarship Golf Outing, which has given out \$392k dollars to 69 children of active members to help pay for their college tuition. We started the Brotherhood Fund, which is 2 cents an hour from the union dues to help the children of any active member who passes away. Since the inception of this fund, we have given out \$40k dollars to 4 children of active members who passed away. We also have increased the balance of the General Fund by \$10 million dollars, even with reducing the union dues twice from 4.5% to 3.5%. Some things that we are looking to do in the future that I have mentioned in a previous Conduit article is putting solar carports and EV charging stations in the parking lot of the union hall. It's been a bit of a process with engineering and the permit process, but I'm pretty confident we will break ground on this project in 2025.

I would like to thank President John Guadagno, Financial Secretary Ryan Casey, retired Financial Secretary James Malley and my entire staff for helping accomplish all of these achievements.

Brothers and Sisters, that ends my report for this issue of the Conduit. Remember to work safe turn off energized circuits, and always stick together out there.

## I.B.E.W. LOCAL 25 **SCHOLARSHIP FUND**

Trustees of the I.B.E.W. Local 25 Scholarship Fund will be accepting tuition scholarship applications from students who have graduated high school in 2024, or currently attending a four-year recognized college or university. The Scholarship requirements are as follows:

- 1. Must be a child who is a dependent of an active member of Local Union #25 in good standing
- 2. Acceptance of study or currently attending a four-year recognized college or university
- 3. Must be a rising freshman, sophomore, junior, or senior currently attending a four-year recognized college or university
- 4. Must have and maintain at least a 2.5 GPA
- 5. Submit a 200-word essay on what unionism and Local 25 has meant to you and your family
- 6. Submit an official high school transcript or a current college transcript if currently attending a four-year college or university at time of application
- 7. Any member who has a child who may qualify **must return** the application, essay, and official transcripts to the Business Office of IBEW Local 25 by June 14, 2025
- 8. Each child can only win one time Applications will be reviewed and awarded to the most qualified candidates.

This upcoming Presidential/Local Election in November 2024 is a pivotal moment in the future of our Local union. We are not going to talk about any other subjects related to this election except for how this election affects IBEW Local 25 members and their families.

Included here is a comparison of the 2 candidates in relation to organized labor.

Presidential nominees Kamala Harris and Donald Trump are in a tight race for the White House. Every voting bloc will count, including members of labor and other people in their households.

The International Brotherhood of Electrical Workers is endorsing Vice President Kamala Harris for President of the United States.

Presidential Nominee, Vice President Kamala Harris:

Labor Historians generally agree that the Biden/Harris administration has the second-strongest labor friendly record, after Franklin D Roosevelt.

The AFL-CIO gave Harris a lifetime score of 98% on her senate voting record pertaining to Labor.

As Vice President, Kamala Harris chaired the White House Task Force on Worker Organizing and Empowerment.

VP Harris was a co-sponsor of the Asuncion Valdivia Heat Illness and Fatality Prevention Act, protecting workers against occupational exposure to excessive heat.

Presidential Nominee, former President Donald Trump:

In 2018, Former President Trump signed 3 executive orders that restrict the labor rights of approximately 950,000 federal government employees who belong to unions.

In 2019, when Trump appointees held

the majority of the NLRB's 5 seats, the board overturned an Obama-Era NLRB ruling mandating speedy elections. However, in 2023 when Bidens appointees were in a majority, the board issued a ruling favorable to unions that rolled back that Trump-era ruling.

More recently, in a highly publicized conversation with Tesla, SpaceX, and X CEO Elon Musk, Trump praised Musk for firing employees who spoke out on workplace problems and attempted to unionize.

Historian Nelson Lichtenstein claims that Trump's years in office were bad for organized labor, which is representative of how labor experts see his track record.

"Vice President Harris has been a proven ally of the IBEW. Working by President Biden's side, she cast the deciding vote to save our pensions. Their administration created good union jobs through the Bipartisan Infrastructure Law, the American Rescue Act, the Inflation Reduction Act and the CHIPS and Science Act," said International President Kenneth W. Cooper.

How IBEW Local 25 households will vote is not clear.

As our former Business Manager, Kevin Harvey, used to say, "We need to vote our wallet."





## PRESCRIPTION BENEFIT REBRAND

## ACTIVE HEALTH PARTICIPANTS ONLY



Magellan Rx, your prescription benefit manager, is rebranding effective October 1<sup>st</sup>, 2024. The new name is *Prime Therapeutics Pharmacy* (see *new logo above*).

The change from Magellan Rx to Prime Therapeutics is mostly a rebrand and name change. Phone numbers, member ID numbers and addresses will not change for you or providers. Prime has been sending communications to all participants and providers with rebrand information.

Please note the timeline below showing communications and changes that you will notice in the next few months.

August 2024- You should have received a letter in the mail indicating the name change.

**9/16/2024**- Magellan Rx Pharmacy, became Prime Therapeutics Pharmacy. Logos on the websites will be different. Banners on the current website and app will inform you of a website/portal for accessing your prescription information.

**10/1/2024**- New member app launch and new online website/portal access. *Look for "Prime Central" in the App Store*. Letters will be mailed with rebranded logos and a QR for the new App installation.

Online member portal on 10/1/2024 will be <u>www.primetherapeutics.com/member</u>



**11/1/2024**- New hard copy ID cards will be mailed to all participants in the Fund; expect them to arrive early to mid-November. You will be able to download ID cards from the new app; you can use your current ID card until you receive the new card.

**12/1/2024**- Current app and current website/portal will be discontinued. You will be able to see your information on the new App and new portal access noted above.

If you are currently on a specialty medication, Prime will reach out to you on your next scheduled delivery to update your payment information.

Your card ID number will not change, therefore any refills you have at retail pharmacies will still be valid after the rebranding. If you are utilizing mail order for your maintenance medication, there is no need to update your billing information on the new portal.


