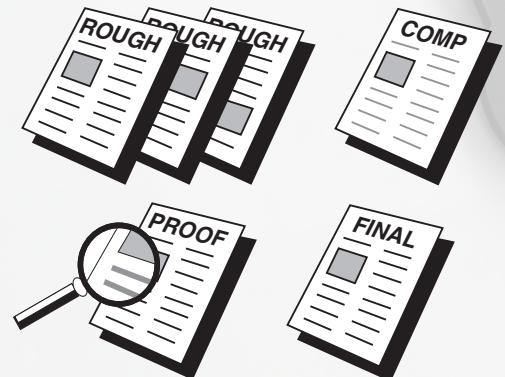

**VOTING INSTRUCTIONS**

**READ THIS BALLOT CAREFULLY BEFORE MARKING**

1. Fill in your ballot inside a privacy booth located in the voting area. If you have questions or need help, ask a GES representative to assist you.
2. Make your selections by completely filling in the circle to the left of the candidate(s) of your choice. Blue or black ink is preferred. No other marks should be used. Do NOT write in the name of a candidate or vote for more candidates than are authorized for each position. If you vote for more candidates than authorized, that section of the ballot will be VOID.



3. If you make a mistake, completely cross out the voting error and clearly mark and indicate your corrected choice. DO NOT PLACE YOUR NAME, INITIALS OR ANY IDENTIFYING MARKS ON THE BALLOT. Your ballot will not be counted if you can be identified. Alternatively, you may bring your incorrectly marked ballot to the GES representative in exchange for a new one.
4. After marking your ballot, refold and place the ballot inside the locked ballot box located in the voting area.
5. You are only allowed to vote once. If you vote in person and mail an Absentee ballot, the in person vote will be counted and the absentee ballot will be VOID.
5. All eligible ballots will be tabulated on June 13, 2023 after polls close at 8:00pm.
6. The election results will be certified by Global Election Services.
